**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.  
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

1. **SWEEPSTAKES PERIOD:** The Bonne Maman A *Basket Worth Sharing* Sweepstakes (“**Sweepstakes**”) begins at 12:00 AM Eastern Time (“**ET**”) on April 1, 2021 and ends at 11:59 PM ET on April 30, 2021 (“**Sweepstakes Period**”). Administrator’s computer is the official time-keeping device for the Sweepstakes.
2. **ELIGIBILITY:** The Sweepstakes is open only to legal residents of the 50 U.S. and DC, who are 18 years of age or older at time of Entry (defined below). Employees of Andros Foods USA, Inc. (“**Sponsor**”), R/West (“**Administrator**”), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies (collectively, “**Released Parties**”), and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not) are not eligible to participate or win. All federal, state, and local laws and regulations apply.
3. **HOW TO ENTER:** During the Sweepstakes Period, visit [www.bonnemaman.us](http://www.bonnemaman.us) (“**Website**”), click on the Sweepstakes link, and follow the instructions to complete and submit the online registration form in order to receive one (1) entry into the Sweepstakes (“**Entry**”). Entries must be received by 11:59 PM ET on April 30, 2021. Limit one (1) Entry per person/household, per email address throughout the Sweepstakes Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant’s Entries and that entrant may be disqualified. If you enter using your mobile phone, standard data rates may apply. See your wireless provider for pricing plan details. Entries generated by script, macro or other automated means and Entries by any means which subvert the Entry process are void. All Entries become the sole property of the Sponsor.

Random drawing will be conducted by Administrator whose decisions are final on all matters relating to the Sweepstakes. Odds of winning will depend upon the number of eligible Entries received.
5. **WINNER NOTIFICATION:** The Prize winners will be required to confirm his/her mailing address via email within seven (7) days of notification attempt or the prize may be forfeited and an alternate winner may be contacted without further notice. Return of prize notification as undeliverable or if notification is not returned in a timely manner, it may result in disqualification

and alternate selection.

PRIZES: Grand Prizes (2):** Two winners will each win a prize package including: one (1) wooden picnic basket (ERV \$199.95) and twelve (12) jars of Bonne Maman Preserves in a variety of flavors (ERV \$5.49 per jar, total ERV of 12 jars \$65.88). The approximate retail value of each prize package is \$265.83. In no event will more than the stated number of prizes listed in these Official Rules be awarded. All federal, state and local taxes are the sole responsibility of each winner. Prizes are non-transferable and no substitutions are permitted, except by Sponsor, who reserves the right, in its sole discretion, to substitute a prize (or portion of prize) of equal or greater value, if prize, or portion of prize, becomes unavailable. No cash redemption of prizes, except at Sponsor's sole discretion. Limit one (1) prize per person.
